## Maintaining your entitlement

- If your application is successful, entitlement will start from the date our school admissions and transport team receive your form.
- Claims are not backdated.
- Claims are reviewed periodically and you will be notified if it is found that your entitlement to free school meals has ceased.
- Free school meals will only continue while you are in receipt of qualifying benefits. Your child's school may request payment for any meals taken while not entitled.
- You must notify our school admissions and transport team immediately of any change of circumstances such as: name, address, benefit entitlement, claimant etc.

## Data Protection Act

This information is being collected to assess your entitlement to free school meals for your child(ren). During processing, your data may be disclosed to: the Department for Work and Pension, Inland Revenue, National Asylum Support Service, Liberata (housing and council tax benefit provider for North Somerset Council) for the purposes of confirming your entitlement to free school meals. The results of any free school meal eligibility check may also be used to assess your entitlement to receive home to school transport. Your data will be disclosed to the school and the school meals provider for the purposes of administering and providing school meals. The information collected may also be used for provided statistical data used to assist with monitoring provision and/or areas of need in order to target future resources. If you have a query or concern about the use of your data, contact the school admissions and transport manager.

## Disclosure of personal information

North Somerset Council has a duty to protect the public funds it administers and to this end, may use the information you have provided within this authority for the prevention and detection of fraud.

## Declaration
